## 2301/10 To consider a community awareness event

The Parish Council had been asked to support a community awareness event to raise awareness of what groups are available to residents on the parish. The Parish Council was generally supportive of the idea and it was **resolved**, with no votes to the contrary, for Cllr Cornell to liaise with the organisers.

#### 2301/11 Boules

Members were informed that there had been a delay from the North Devon Council taking a report to Committee to allocate the Section 106 funding, the proposal will now go to NDC's committee in early February. It was **resolved**, with no votes to the contrary, to note the information.

### 2301/12 Jubilee Fountain and Bus Shelter

Cllr Cornell reported that a carpenter could repair the bus shelter with a quotation of £800 it was **resolved**, with no votes to the contrary, to proceed if the quotation could be reduced to £650. Cllr Stanbury will continue to investigate repairs to the Jubilee Fountain, and it was agreed to investigate the option of barriers in front to prevent further damage.

### 2301/13 **Play Areas**

Members considered the remedial works required following the annual inspections it was noted that the slide in the Recreation Field is not the wrong way around and it was resolved, with no votes to the contrary, to ask TK Play to provide a quotation for a replacement gate on the Manor Hall.

#### 2301/14 Budgets & Precept

Members considered the impact and it was **resolved**, with no votes to the contrary, to agree the budgets and a precept of £23,589.56.



## 2301/15 **Gritt Bins**

Members felt the top of Haggington Hill required a gritt bin Cllr Latham will seek written permission from the landowner to site the bin and it was agreed to investigate moving the bin from Crosspark to the top of Haggington Hill.

# 2301/16 **Berrynarbor Car Park**

Cllr Stanbury reported that he had spoken to the officer at NDC and they were looking to prepare draft heads of terms removing the liability for the bank for consideration.
