

b) To consider installation of the basket swing. Members considered suitable locations for the installation of the basket swing and it was agreed for Cllr Bacon to seek quotations to dig out the bank and place the swing in the bank next to the pedestrian pathway.

2311/09 North Devon Record Office

Members considered a request for financial assistance, and it was **resolved**, with no votes to the contrary, to provide a donation to the North Devon Record Office of £50.

2311/10 Claude's Garden

- a) To note appointment of new trustees Members were informed of the appointment of new trustees, and it was **resolved**, with no votes to the contrary, to note the information.
- b) To receive and consider the health of one of the trees in Claude's Garden Members were informed that the Tree Surgeon had confirmed that the tree in Claude's Garden has been poisoned due to the way in which it is dying from the bottom up, it might rejuvenate in spring. It was **resolved**, with no votes to the contrary, to see if the tree does rejuvenate in spring and if not to replace the tree with a similar size tree or bigger, Claude's Garden will remain closed whilst the situation is monitored.



2311/11 Certificate of Lawfulness

Members had received a request to provide any relevant information relating to a Certificate of Lawfulness for Watermouth Castle. Members noted that it had been in operation as a theme park for over ten years and probably closer to 40 years.

Bus Fares Capped at £2

Reminder that all bus fares are caped at £2 which makes taking the 301 into Barnstaple extremely good value, saves on parking chares and helps reduce congestion and emissions.

Household Support Fund

Earlier this year DCC secured £10m from the fourth round of the Government's Household Support Fund to cover the period from April 2023 until March 2024

The money comes with conditions on how it can be allocated and is to support households in most need – those that are struggling to pay for food, energy, water bills and other related essentials. It is also intended for those that may not be eligible for other government support.

So far under this fourth round of the scheme, over £5 million has been used to support more than 38,000 households across Devon.

And now with winter approaching, DCC are working with Team Devon partners (district and city councils) and other community organisations to provide our most vulnerable residents with rapid short-term financial support to help them over the coming months.

The homeless, low income families, those who are suffering from ill health and ethnic minorities are just some of the many groups who will benefit from schemes including free school meal holiday vouchers, hardship payments, pre-payment and credit energy meter support, community grants and funding for minor energy efficiency measures.

For this coming winter, Devon's district and city councils have over £2 million to offer 'one-off' financial help to those who are struggling to pay for their food and utility costs or other household essentials. Help may also be available for unexpected or exceptional circumstances, for example, rent arrears prior to being in receipt of appropriate housing benefits.

DCC are also working with the Devon Community Foundation to provide grants to voluntary sector organisations supporting communities that don't always get the help they need. Their 'Food, Fuel and More' grant scheme was very well received earlier this year and will re-open this winter with a further funding pot of over £260,000.

The scheme will offer large grants of up to £25,000 to organisations that support homeless people or people in temporary or insecure housing. Groups supporting households with disabled residents or those suffering ill-health which has a direct impact on household income and an ability to meet food and energy bills, are also encouraged to apply, along with organisations that support Asian, black, traveller, Gypsy, Roma and ethnic minority communities who are not accessing support through other channels. They will also be operating a small grants scheme of up to £2,000 for smaller community initiatives.
