It was **resolved**, with no votes to the contrary, to approve the payments and receipts.

### 2409/07 Social Media

Members were informed that the Facebook page was up and running, however, there are not many followers, it was agreed that the Clerk should also be an administrator for the page.

A member of the public had made an offer to edit a parish newsletter, it was agreed that both parties would need to understand how the information is fed to them, and it was agreed to ask the member of the public to produce some information on how it would operate and what they need.

### 2409/08 Recreation Field

- a) To further consider provision of a toilet. It was noted that it had been agreed to defer this item until after the community survey.
- b) To receive an update on the community survey.

  Cllr Young confirmed that as of yesterday there had only been 110 responses, it was agreed to undertake a further drop-in session and request an extension. The Chairman expressed their frustration at the lack of responses, she explained that the Parish Council is committed to this and needs to get the most out of it that it can, she encouraged everyone to respond even if they did not wish to see any changes. It was noted that

visitors will be identifiable as there is a section with how far people live from Berrynarbor.

c) To receive feedback from the mini festival.

Cllr Young and Boxall confirmed that the event had gone well and had raised approximately £220, they felt it should become an annual event on the bank holiday weekend after the Manor Hall fete and not the same weekend as Ilfracombe Sea.

d) To receive an update on the purchase of a wooden pavilion. Members were notified that confirmation had been received from NDC that the structure would not require planning permission. It had been suggested that volunteers would build the base and agreed for Cllr Young and Stanbury to meet the volunteers on site to agree the exact location and specification for the base, it was noted that Cllrs would also need to verify the competence of the volunteers to undertake the task prior to any agreement.

### 2409/09 **Emails**

Members are unhappy with the new email system; they do not find it easy to use and there is a lot of spam email. It was agreed to investigate other systems and/or providers and look to change to a .gov.uk domain at the same time.
