1711/02 **Declarations of Interest**

Cllr Mrs Reynolds declared a Personal and Prejudicial Interest in Item 1711/08 Planning Application 63944 as the applicant is a neighbour and friend, a Disclosable Pecuniary Interest in Item 1711/19 as her personal property is affected and a Personal Interest in Item 1711/06 and 1711/13 as she has a child at the school.

It was **resolved**, with no votes to the contrary, to approve the payments.

1711/11 To receive budget review

The budget review and bank reconciliation were circulated prior to the meeting and it was **resolved**, with no votes to the contrary, to note the information.

1711/12 To consider draft budgets for the financial year 2018/2019

The draft budgets were circulated prior to the meeting. Members were informed that the Parish Grant would be cut by 50% in 2018/2019 and reduced to zero the following year. The reduction for 2018/2019 represented an increase of 2.8% on the precept. Members considered the drat budgets, increase in costs and impact on the Council Tax and it was **resolved**, with no votes to the contrary, to defer the draft budgets until the next meeting for further consideration.

1711/13 To agree the removal of the Basket Swing from the Recreation Field and consider donation to the school

It was **resolved**, with no votes to the contrary, to appoint Wicksteed to remove the Basket Swing prior to the 31st January 2018 and as soon as reasonably possible. It was further **resolved**, with no votes to the contrary, to donate the basket swing and frame to the Berrynarbor Primary School.

The School had been approached and would really like to have the basket swing for the children to use, however, the school had confirmed that for Health & Safety



reasons it would only be able to employ the services of the play installation company that had initially provided and installed the equipment and currently the school does not have the funds to pay for the installation and new grass matting that would be required.

It was noted that pledges of private donations had been made towards the installation of the basket swing at the school and it was **resolved**, with no votes to the contrary, to seek further donations, to place an article in the newsletter requesting private donations from anyone that would like to help and to install the swing at the school using the donations

1711/14 To consider Tenders for the creation of a stone planter

Members considered the tenders received.

Cllrs Lovering and Mrs Gubb left the meeting and did not return.

It was **resolved**, with no votes to the contrary, to accept the tender from Berry Arboriculture to create the stone planter.

Cllr Coppin left the meeting.

1711/15 To agree Calendar of Meetings for 2018

It was **resolved**, with no votes to the contrary, to agree the Calendar of Meetings for 2018.

1711/16 To consider donation towards the Royal British Legion Poppy Appeal It was resolved, with no votes to the contrary, to give a donation of £25.

Cllr Coppin returned to the meeting.

1711/17 To consider donation towards the Torridge, North, Mid and West Devon Citizens' Advice

It was **resolved**, with no votes to the contrary, to give a donation of £50.

1711/18 To consider Tenders for fencing the play area at the Recreation Field

The Chairman reported that South West Water had been contacted and asked if it could contribute towards the cost of the fencing, the request was being consider and it was **resolved**, with no votes to the contrary, to defer the item to the next meeting to allow the contribution to be considered by South West Water.

Cllr Mrs Reynolds declared a Disclosable Pecuniary Interest and left the meeting for the following item.

1711/19 To receive notification of the Local Inquiry for Title Order: (Restricted Byway No.27, Berrynarbor)

It was **resolved**, with no votes to the contrary, to note the information.

Cllr Mrs Reynolds returned to the meeting.

1711/20 To consider winner and prize for the Flag Design Competition

Members considered the entries, a winner was chosen along with two runner ups and a highly commended, it was **resolved**, with no votes to the contrary to have the winning design made into a flag and to investigate the possibility of flying the flag.



1711/21	To consider options and details for the future management/ownership of the car park and public toilets It was noted that the District Council was still investigating the options and it was resolved, with no votes to the contrary, to defer until the next meeting.
1711/22	To consider growing a Christmas Tree for the village (Cllr Stanbury to report) Cllr Stanbury was still investigating the feasibility and it was resolved , with no votes to the contrary, to defer until the next meeting.
1711/23	To discuss cleaning arrangements for the public toilets (item requested by Cllr Mrs Fairchild) Cllr Mrs Fairchild reported that she had been inspecting the toilets weekly and they were being cleaned to an acceptable standard but did ask if it would be possible to order some toilet rolls for the dispensers. It was resolved, with no votes to the contrary, to order the toilet rolls.
1711/24	To consider extra gilding to Village Signs (Cllr Mrs Barten to report) Cllr Mrs Barten explained that the cross bars on the signs would look better if gilded at a total cost of £60. It was resolved, with no votes to the contrary, to have the cross bars gilded. A quotation had been received to transport the signs to the contractor's premises and it was resolved, with no votes to the contrary, that Cllr Stanbury would collect the signs and deliver to the contractor's premises.

1711/26	To consider correspondence arising from a recent Freedom of Information Request Members considered the correspondence and the reply and felt that the subject of the location of the play equipment in the Recreation Field had been dealt with at length, it was noted that the issue had cost the Council significant time and resources and it was resolved, with no votes to the contrary, that any further correspondence relating to the nuisance claim and the location of the play equipment would be treated as vexatious and the Parish Council would not enter into further discussion or correspondence. It was further resolved, with no votes to the contrary, to place an article in the parish newsletter
